1) Welcome: MF welcomed all to the meeting

3) Public Participation: Allotment tenant complained about hens escaping from neighbouring plots and destroying plants and vegetables amounting to hundreds of pounds. The tenant askes the Parish Council as owners of the land to take action against tenants who ignore the rules of the tenancy agreement. Discussions on options as to how to deal with the matter, an Allotment Committee Member agreed that it was a problem and that the committee had responded by placing notices up around the allotments reminding tenants that they have a responsibility to ensure hens are secured on their plots only. It was agreed that the Parish Council would release a letter to all plot holders informing them that the persistent escapes of hens from their plot would result in the tenant's immediate removal of the hens from the allotment.
